(*) The tax increases within that tax bracket range according to the ISEE status.

(1) Exemption based on income (“No tax area”)

Students with an ISEE status equal or lower than €6,500.00 and who do not satisfy the merit requirement envisaged at letter b) of the aforesaid Exemption Law 232/2016, receive a **partial exemption, meaning they do not have to pay the total fee foreseen in the second and third instalment.**

This exemption applies upon payment of the first instalment equal to € 561.00.

(2) Exemption envisaged by Law 232/2016

Total exemption from paying the total annual fee is envisaged, and the sum paid on the first instalment is accordingly **refunded**, to students who belong to a family whose ISEE is lower than or equal to 13,000.00 and who satisfy both the following requirements:

a) **Enrolment:** they are enrolled at the university concerned for a number of academic years lower than or equal to the normal course length, increased by one.

b) **Merit:** they achieved at least 10 university credits by 1st August of the first academic year, if they are enrolled in the second academic year. They achieved at least 25 university credits in the twelve months before 10th August of the year prior to their enrolment, if they are enrolled in any of the subsequent academic years. Merit is not considered for the first year’s enrolment.

Stamp duty and regional tax for the university right to study still have to be paid.

If they satisfy **just the merit** requirement (letter b) and are not correctly enrolled (letter a), the total fee is €200.00.

It should be remembered that other reductions are envisaged based on the high-school leaving grade and other forms of exemption.
